The Clerk updated Councillors that two quotes had been received for filming the virtual switch-on; Quote A for £540, Quote B for £1145. Discussion were held about the merits of each quote. Cllr Thomas asked for a proposal to be put to accept Quote A – this was proposed by Cllr M Hickman, and seconded by Cllr N Tatam, with all in favour.</p> <p>The Clerk's report on the Town Team was received and noted, with all Councillors commending the great work they are doing.
