- ii) The Recovery Toolkit for Young People who have experienced Domestic Abuse

Both courses would enable us to offer practical and emotional support to women and young people in a peer setting, helping them to flourish in a life free of abuse. The Recovery Toolkit, which is a follow-on from the Freedom Programme, enables people to better evaluate their options and plan for their future.

The programme is currently on offer across Gwent, however, we no longer have anyone trained to deliver the programme in Monmouthshire. We would like support to train our staff so that we can deliver two groups in Abergavenny over the next twelve months. We have the staff in place to do so, and once trained, they will have to commit to remaining with the organisation for 2 years.

## Project Breakdown

£900 Recovery Toolkit Training Fee

£195 Hotel Costs 2 Nights in London plus meals

£120 Train Costs to London

£1,500 Cost to deliver two groups (staff time, volunteer costs, room costs, refreshments, and resources)

We would like support towards the training costs, which is only available in London, and hotel/transport costs. The funding for the remaining costs and delivery of the groups will come from our existing funding and the charity's reserves.

g. How will your project benefit the community of Abergavenny?

Once the training is undertaken, we will deliver two programmes, one for adults and one for young people.

Approximately 1 in 3 women will experience domestic abuse in their lifetime, and 1 in 4 will experience it from a partner/ex-partner. Leaving an abusive relationship is incredibly difficult, not only is it a time of high physical risk, the abuse can destroy women and children's self-esteem making it feel impossible that they can make a fresh start from their abuser. Once leaving, women and children can exhibit post-traumatic stress disorder, have difficulty in sleeping, can feel isolated, and face increased risk of self-harm or suicide.

Both Recovery Toolkit groups, will support women and young people in Abergavenny to:

- Meet people with similar experiences, increase their social network, and reduce their feelings of isolation.
- Re-evaluate for themselves how they might move forward with their lives and make better-informed choices about their future.
- Re-inforce their own strengths, resources, and resilience to positively improve their long-term wellbeing.

Whilst we have run the Adult Recovery Toolkit previously in Abergavenny, we have not had the opportunity to deliver the Young People programme.
