a. Briefly tells us about the activities that your organisation/group undertakes

The Trust promotes sustainable behaviours, encourages participation and social inclusion, supports families in their various forms and facilitates educational, social, welfare, leisure and recreational activities to enable people to mix together.

The Abergavenny Community Centre is a 'cradle to the grave' place that brings people together to do everyday things, keeping more people active and involved.

The Centre is a community resource. In addition to its own charitable activities we encourage other organisations and individuals to use the multi-purpose space for private ventures and for delivering services. Having a shared space is widening the reach of the Centre, enabling more people to access emergency food and participate in activities.

The small, part time team is supported by twenty volunteers who come regularly to help out at coffee morning, lunches, gardening, toddlers group, dementia friendship cafe, singing, chair yoga, knitting club and the monthly Sunday afternoon teas. Other social events and activities convened throughout the year include:- The Big Lunch, World Bistros [inspired by Abergavenny's cultural landscape]; outside space for the Orchard group to host Apple Pressing days; the annual Seedy Sunday [seed swap] event; and the annual plant sale that raises funds for WaterAid.

Furthermore, in response to needs expressed by residents the Trust is developing its 'Supporting Families' work. The Community Centre is becoming known in the area for delivering accessible, engaging and meaningful family-centred activities. Currently, there are more than 120 families on the combined half term, summer holidays, 'hands-on cooking' and community kids' registers. Last Summer (Aug 2023) 102 children participated in the holiday programme consisting of outdoor learning & play, art club and 'cooking for life' activities. For a second year, demand for the places on the Art Club and Cooking activities exceeded our ability to supply. Over the October Half Term, with our partners, we offered Origami sessions - attended by 30 children and family members, two craft sessions, a hands-on cooking activity and our first halloween disco was attended by forty-five children/adults with many of those coming to the Centre for the first time.
