Public present: Owen Lewis: Owen wished to ask Council about support for Banks on the High Street in Abergavenny. He has met previously with Cllr Wright and the Principal Officer as well as MP for Monmouthshire Catherine Fookes, who spoke about banks on the High Street in Parliament. Not keen on hubs, as they will still be unable to service many who are vulnerable or need support. Are Halifax going to have a presence in with Lloyds? Vulnerable or Older People need and want to use cash, It is also a chance to speak to someone and these people may help to spot any potential victims of scams. Would like to see support for the banks that remain on the High Street. Can the Council find out more behind the rationale of why there is so much support for banking hubs? The petition he gathered highlighted similar concerns to those discussed by Councillors. Banks make the town good and safer to use as so many are nervous with using online facilities. Councillors commented that most business banking can be done online as for individuals, but the lack of somewhere to get or pay in cash affects independent retailers. Charities suffer as there is nowhere to pay in cash. It was discussed if Council can support the use of cash, and defend those banks that remain on the High Street by way of a statement of support. Suggested that Chair of Committee should write to MP about this. Councillors could contact each branch we still have to offer support and to lobby to keep them there. Many in our community still rely on cash, and don't even have bank accounts, and vulnerable adults need cash support as their support workers give them their allowance weekly, so need an in person facility. Can't put a price on the in person interactions. Email to ask for update from MP, with a view to



One overarching comment we keep getting, is that there is so much on, people don't know where to look.</p> <p>Cllr G Wilde asked if Mike Skilton from Black Mountain Jazz can be invited to the next one as they are organising a Community Day on Sunday 28th September. Cllr Barnes asked if we had received any information on the Country and Western Festival happening in May.
